Population health profile of the Westgate Division of General Practice: supplement



Population

The Westgate Division had an Estimated Resident Population of 200,728 at 30 June 2005.


Over the five years from 1991 to 1996, the Division's population increased by 2.3% on average each year, substantially above the level in Melbourne (0.8%), Victoria (0.6%) and Australia as a whole (1.2%). From 1996 to 2001, the annual percentage increase was again 2.3%, again higher than Melbourne (1.3%), Victoria (1.2%) and Australia (1.3%). From 2001 to 2005, the population increase of 3.9% was almost four times the annual increases in Melbourne, Victoria and Australia.


Figure 2: Population in Westgate DGP and Australia, by age and sex, 2005

As shown in the accompanying table and the age-sex pyramid (Figure 2), the Westgate DGP had relatively more children aged 0 to 14 years (21.7%) and people in the 25 to 44 year age group (33.0%) than Australia as a whole (with 19.6% and 28.9%) (Table 1). Conversely, the 45 years and over age groups had markedly lower proportions compared to Australia as a whole.

The most notable differences in the age distribution of the Division's population (when compared to Australia overall) are:

- at younger ages – a higher proportion of children aged 0 to 14 years;
- from 15 to 24 years – a smaller proportion of males;
- from 25 to 49 years – higher proportions of both males and females; and
- from 50 years and over – lower proportions of both males and females.

Figure 3: Population projections for Westgate DGP, by age and sex, 2005 and 2020




The population projections for the Division show a number of changes in age distribution, with the 2020 population projected to have:

- at younger ages – lower proportions of children, teenagers and young adults, aged 0 to 24 years;
- from 25 to 44 years – lower proportions of both males and females; and
- from 45 years onwards – higher proportions of both males and females.

One of four socioeconomic indexes for areas produced at the 2001 ABS Census is the Index of Relative Socio-Economic Disadvantage.

The Westgate DGP has an index score of 998, marginally below the score for Australia of 1000: this score varies across the Division, from 896 in the most disadvantaged areas to 1086 in the least disadvantaged areas.


Note: each 'quintile' comprises approximately 20% of the population of the Division.

A new indicator, produced for the first time at the 2001 ABS Census, shows the number of jobless families with children under 15 years of age. There were slightly more jobless families in the Westgate DGP (15.9%), compared to Melbourne as a whole (14.7%) (Figure 5, Table 2).

With the introduction of the 30% rebate for private health insurance premiums, there was a once-off registration process, providing information of the postcode and residence of those who had such insurance (these data are not available at this area level for later dates). In 2001, the Division had a markedly lower proportion of people with private health insurance (39.0%), compared to Melbourne (49.2%) (Figure 5, Table 2).

Private health insurance, 30 June






GP services to residents of the Westgate DGP

The following tables include information, purchased from Medicare Australia, of the movement of patients and GPs between Divisions. Note that the data only include unreferred attendances recorded under Medicare: unreferred attendances not included are those for which the cost is met by the Department of Veterans' Affairs or a compensation scheme; or are provided by salaried medical officers in hospitals, community health services or Aboriginal Medical Services, and which are not billed to Medicare. At any attendance, one or more services may have been provided.

Over three quarters (77.9%) of all unreferred attendances to residents of Westgate DGP were provided in the Division (ie. by a GP with a provider number in the Division): this represented 674,121 GP unreferred attendances (Table 3). A further 10.1% of unreferred attendances to residents were provided by GPs with a provider number in Western Melbourne DGP.

The majority (91.1%) of unreferred attendances provided by GPs with a provider number in Westgate DGP were to people living in the Division (ie. their Medicare address was in the Division) (Table 4). A further 3.7% of unreferred attendances provided by GPs in the Division were to residents of Western Melbourne DGP.

Additional prevalence estimates: chronic diseases and risk factors combined

Please refer to the earlier *Population health profile of the Westgate Division of General Practice*, dated November 2005, available from www.publichealth.gov.au, for the separate prevalence estimates of chronic disease; measures of self-reported health and risk factors. The process by which the estimates have been made, and details of their limitations, are also described in the 'Notes on the data' section of this earlier profile.

In this section two estimates, which combine the prevalence of selected chronic diseases with a risk factor, are shown for the Division. The measures are of people who *had asthma and were smokers*, and people who *had type 2 diabetes and were overweight or obese*: note that the estimates have been predicted from self-reported data, and are not based on clinical records or physical measures.

It is estimated that there were relatively more people in Westgate DGP who had asthma and were smokers, compared to Melbourne or Australia as a whole (Figure 6, Table 5): that is, the prevalence rates per 1,000 population were higher. There were also relatively more people in Westgate DGP who had type 2 diabetes and were overweight/ obese, compared to Melbourne or Australia, although the difference was not great.

Avoidable hospitalisations: hospital admissions resulting from ambulatory care sensitive conditions

The rationale underlying the concept of avoidable hospitalisations is that timely and effective care of certain conditions, delivered in a primary care setting, can reduce the risk of hospitalisation. Admissions to hospital for these ambulatory care sensitive (ACS) conditions can be avoided in three ways. Firstly, for conditions that are usually preventable through immunisation or nutritional intervention, disease can be prevented almost entirely. Secondly, diseases or conditions that can lead to rapid onset problems, such as dehydration and gastroenteritis, can be treated. Thirdly, chronic conditions, such as congestive heart failure, can be managed to prevent or reduce the severity of acute flare-ups to avoid hospitalisation.

This measure does not include other aspects of avoidable morbidity, namely potentially preventable hospitalisations (hospitalisations resulting from diseases preventable through population based health promotion strategies, e.g. alcohol-related conditions; and most cases of lung cancer) and hospitalisations avoidable through injury prevention (e.g. road traffic accidents).

In 2001 to 2002, the 4,844 admissions from ambulatory care sensitive (ACS) conditions accounted for 8.6% of all hospitalisations in Westgate DGP (Table 6, Figure 7), consistent with the levels in Victoria (8.8%) and Australia (8.7%).



Figure 7: Avoidable hospitalisations¹, Westgate DGP, Victoria and Australia, 2001/02




The rate of avoidable hospitalisations in Westgate DGP, 3,149.2 admissions per 100,000 population, is higher than the rates for Victoria (a rate of 2,983.2) and for Australia (2,847.5).

Diabetes complications, chronic obstructive pulmonary disease, congestive heart failure and angina were the four conditions with the highest rates of avoidable hospitalisations in the Westgate DGP (Figure 8, Table 7).

Table 7 shows the number, rate and proportion of avoidable hospitalisations, for the individual ACS conditions, as well as the vaccine-preventable; acute; and chronic sub-categories. The majority of avoidable hospitalisations are attributable to chronic health conditions. The predominance of hospitalisations for chronic conditions in this period can be primarily attributed to the large number of admissions for diabetes complications. Dental conditions and cellulitis have the highest rates of avoidable hospitalisations for the acute conditions.

Avoidable mortality

Avoidable and amenable mortality comprises those causes of death that are potentially avoidable at the present time, given available knowledge about social and economic policy impacts, health behaviours, and health care (the latter relating to the subset of amenable causes).

For information on the avoidable and amenable mortality conditions and ICD codes included in the analysis in this section, please refer to the *Australian and New Zealand Atlas of Avoidable Mortality*, available from www.publichealth.gov.au.

Over two-thirds (71.0%) of all deaths in Westgate DGP at ages 0 to 74 years over the period 1997 to 2001 are considered to be avoidable, the same as the proportion for Melbourne (71.0%) (Table 8). However, the rate in the Division is notably (13%) higher than that in Melbourne.

Deaths amenable to health care (amenable mortality, a subset of avoidable mortality) accounted for 28.0% of all deaths at ages 0 to 74 years in Westgate DGP, also consistent with 28.7% in Melbourne.

Rates of avoidable mortality were higher for males than for females in each of the comparator areas. Westgate DGP's rate of avoidable mortality for males was 279.7 deaths per 100,000 males, higher than the rate of 156.2 for females. The rate of amenable mortality for males in the Division was also higher, 95.0, compared to 78.9 for females, a rate ratio of 1.20 (Figure 9, Table 9).

Note: the different scales



Another way of measuring premature mortality is to calculate the number of years of life lost (YLL)¹, which takes into account the years a person could have expected to live at each age of death based on the average life expectancy at that age.

The numbers of YLL for Westgate DGP, Melbourne, Victoria and Australia over the period of analysis are shown in Table 10 by mortality category. However, given the substantial variation in the populations of these areas, a comparison of the proportion of YLL for each area is also shown.

YLL from avoidable mortality accounted for 71.3% of total YLL (0 to 74 years) for Westgate DGP, consistent with the proportion for Melbourne. The proportion of YLL from amenable mortality for Westgate DGP (27.6%) was marginally lower than for Melbourne (28.1%).

In each of the areas in Table 11, the majority of avoidable mortality at ages 0 to 74 years occurred in the 65 to 74 year age group (Table 11), with 1,478.8 deaths per 100,000 population in the Westgate Division. The 45 to 64 year age group accounted for the next highest rate of avoidable death in all of the comparators, with a rate 307.2 in the Westgate Division.

Table 12 shows the number and age-standardised death rate by selected major condition group and selected causes included in the avoidable mortality classification.

The highest rates of avoidable mortality for the selected major condition groups in the Westgate DGP were for cancer, with a rate of 75.6 deaths per 100,000 population, and cardiovascular diseases, 67.9 deaths per 100,000 population (Table 12, Figure 10). For the selected causes within the condition groups, the two major causes of avoidable mortality were ischaemic heart disease and lung cancer, with rates of 50.3 per 100,000 population and 26.5 per 100,000, respectively.



Rates in the Division were generally above, or consistent with, those for Melbourne and Australia: the main exceptions were for colorectal cancer, respiratory system diseases (total and COPD) and road traffic injuries (Figure 10).
